

Washington Redskins Cheerleader Auditions Waiver and Release

The undersigned requests that she be allowed to demonstrate her skills and ability as a contestant during the auditions for the Washington Redskins Cheerleaders. In consideration of being afforded such opportunity, the undersigned hereby assumes any and all risk of injury involved in such demonstrations and agrees to release and discharge Pro-Football, Inc. d/b/a the Washington Redskins, any parent, subsidiary, affiliate, successor, predecessor, or otherwise related companies, and the past, present, and future employees, agents, officers, attorneys, directors, shareholders and employee benefit programs of any of them, and their agents and insurers, from all claims of any nature whatsoever, for any injuries that may be sustained by the undersigned during such demonstration and auditions. The undersigned also acknowledges that the Washington Redskins have not arranged for, nor carry, any insurance of any kind for her benefit or that of her heirs, executors and administrators relative to her participation in the auditions; and that she is solely responsible for obtaining and paying for any life, accident, automobile, property or other insurance regarding her participation in the auditions.

The undersigned hereby agrees that she may be photographed, videotaped and otherwise recorded by the Washington Redskins or their representative during the auditions (collectively, "Footage"). Footage will be owned by the Washington Redskins, who, along with their designees, have the right to use, edit, adapt, post, stream, copy and exploit such Footage and all elements embodied therein, including any names and likenesses embodied therein, in any and all media now known or hereafter devised throughout the world, in perpetuity, for advertising, promotional, trade and other purposes. By attending the auditions, the undersigned agrees that her name and likeness may be included in the Footage, in the Washington Redskins' sole discretion, without any compensation to or permission from, the undersigned.

The undersigned recognizes and understands that she may not be selected as a Washington Redskins Cheerleader and agrees to hold the Washington Redskins, along with any parent, subsidiary or affiliate harmless if, for any reason whatsoever, she is not selected as a Washington Redskins Cheerleader. The undersigned understands that taking the prep class does not guarantee she will be selected to be a Washington Redskins Cheerleader.

By signing this Washington Redskins Cheerleader Waiver and Release, the undersigned warrants that she is at least (18) years of age. The undersigned warrants and represents that she has the full right and power to enter into this waiver and release.

The undersigned agrees that this waiver and release supersedes any prior understandings between herself and the Redskins relating to the auditions and the rights granted herein and no provision of this Waiver and Release can be modified by any other instrument, invoice or document unless in writing and signed by the parties hereto.

It is understood and agreed that this is a complete RELEASE and DISCHARGE of all claims and rights of the undersigned against the Washington Redskins, and that no action will be taken by or on behalf of the undersigned with respect to any such rights; it being understood that this release shall be binding upon the parents, guardians, heirs, executors, and administrators of the undersigned.
